"As far as is known to Defendant, no cases of Mad Cow disease have ever been found in the United States." Footnote 20, page 13, Brief in Support of Defendant Tim Curry's Motion for Summary Judgment and Response to Plaintiffs' Motion for Summary Judgment.

The representation was true at the time it was made and for months thereafter.

Three months have passed. Federal governmental officials have in the past few days publicly stated that the first case of bovine spongiform encephalopathy (BSE), also known as Mad Cow disease, has been confirmed in a cow in the United States. Accordingly, Defendant now updates and corrects the representation made in September 2003 by the filing of this document.
