This is in response to your April 1, 2006, Freedom of Information Act (FOIA) request for all owner/shipper papers of horses transported to slaughter by or for G and B Livestock of Boyd, Texas. Your request was received in this office on April 3, 2006, and assigned case number FOIA 06-489. We apologize for the delay of this response.

Agency employees conducted a thorough search of their files and located 11 pages of responsive records. However, information has been withheld under FOIA Exemption 6, 5 U.S.C. § 552(b)(6). This exemption protects information from disclosure when its release would cause a clearly unwarranted invasion of personal privacy.

You may appeal our denial of this information. If you choose to appeal, your appeal must be in writing and must be received within 45 days of the date of this letter. Send to:

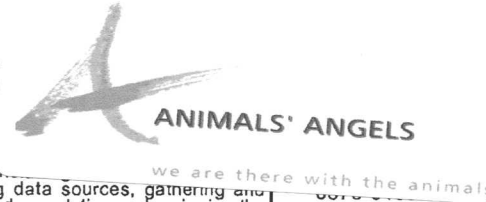
