ORDER GRANTING PLAINTIFF'S MOTION FOR RELIEF FROM ORDER DISMISSING DEFENDANT WALTON AND VACATING ORDER GRANTING WALTON'S MOTION TO DISMISS

Pending before the Court is plaintiff Dallas Crown's Motion for Relief From Order Dismissing Defendant Ed Walton [doc. # 76-1], filed April 28, 2003. In the motion, Dallas Crown requests relief from the Court's April 22, 2003, order that dismissed all the plaintiffs' claims against Walton. 
